CONSULTANT AGREEMENT

THIS AGREEMENT, effective / /20 , is between , a **CLIENT** of , New Zealand, hereinafter referred to as **THE CLIENT** and NazPI Ltd, hereinafter referred to as the **Consultant**.

1.0 SERVICES

THE CONSULTANT provides services to maximise the negotiated use of techniques for speedy and efficient resolution of commercial and employment disputes. The services include advice to assist businesses and individuals concerning contract disputes without the need to go to court, but will provide help in the proposal of independent dispute resolution facilitators and legal representation by referral.

2 CONSULTANCY FEES

2.1 **THE CLIENT** shall pay the Consultant a non refundable fee of \$300.00 + GST at the signing of this agreement. This fee includes meeting with **THE CLIENT**, drafting and completing initial correspondence and exchanges on behalf of **THE CLIENT**. The Consultant shall perform these services during the term of this agreement provided that the number of hours does not exceed 2 hours. It includes administration expenses. After the expiration of the initial charge, fees will increase by the application of the following charges in addition to the hourly rate of \$170.00 as 10 units per hour of 6 minutes:

- 2.1.2 Travel expenses necessary in order to perform services required by this agreement shall be charged at the rate of \$0.90 per kilometre.
- 2.1.3 Parking expenses incurred while performing the services required by this agreement will be charged as a disbursement.
- 2.1.4 Telephone, email, printing, photocopying and reproduction charges incurred while performing the services required by this agreement will be charged as a disbursement.
- 2.1.5 Filing fees, Legal referrals and other expenses incurred while performing the services required by this agreement will be charged as a disbursement.
- 2.1.6 All disbursements will be subject to a surcharge of 10%.
- 2.1.7 Overdue amounts will have added a charge of 1.5% per month at the Consultants discretion. **THE CLIENT** shall pay any expenses, disbursements, debt collection agency fees and/or legal costs incurred by the Consultant in the collection of any amount owing by **THE CLIENT** after the due date for payment.

3 CONFIDENTIALITY

- 3.1.2 The Consultant shall undertake not to disclose data or information pertaining to the services assigned to him by **THE CLIENT** without the prior written consent of **THE CLIENT**. The Consultant agrees to return all documentation provided by **THE CLIENT** with all such documents and information treated in the strictest of confidence.
- 3.1.3 The Consultant retains ownership of all files in respect of the services provided to **THE CLIENT** until such time as all accounts are paid in full.
